IN 2012, LUCKY DOG SAVED 1,262 ANIMALS FROM CERTAIN EUTHANASIA IN HIGH-KILL SHELTERS THROUGHOUT SOUTH CAROLINA, NORTH CAROLINA, VIRGINIA, WEST VIRGINIA, AND MARYLAND. THE VAST MAJORITY OF THESE DOGS WERE PLACED IN CAREFULLY SCREENED, LOVING ADOPTIVE HOMES. THOSE THAT WERE NOT ADOPTED IN 2012 REMAINED IN FOSTER CARE INTO 2013 WHERE THEY STAYED UNTIL THEY FOUND THEIR OWN ADOPTIVE HOMES.
